
representatives, administrators, and assignees) agrees to assist **Ms. Arpita Ghosh**, the Secretary, Pancham Vaidic theatre group (here in after abbreviated as PVTG and referred to as party II) (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assignees) to carry out Seminars/ Workshops/ Certificate course etc. and Research, Training on Fine Arts for the holistic development of the students and faculty members. PVTG will provide the expertise and resource persons whereas SCC will provide students and participants and space to carry out the training cum other activities.

2. General Terms and Conditions of MOU:

- (i) **Duration of MOU:** This MOU shall be operational upon signing and will have an initial duration of three years (03 yrs).
- (ii) **Coordination:** To carry out and fulfill the aims and scopes of this MOU, both institutes will nominate or authorized a Person as Representative of any to look upon the activities.
- (iii) **Termination of MOU:** The partnership covered by this MOU shall in general terminate upon completion of the agreed schedule i.e., 3 yrs. However, this Memorandum may be terminated with one month written notice from either end of two parties
- (iv) **Extension of Agreement:** The MOU may be extended by the parties on mutual agreement after completion of the tenure of the MoU.
- (v) **Financial Liability:** As such there will be no financial liability from the ends of both parties. The Certificate Courses run will be chargeable as per the requirement of PVTG. For any other financial matter the decision will be taken by both the parties after mutual discussion
